SECTION 01 — THE REPORT AS FILED

Report record

Public Law 119-12 sec. 3(a)(1)(B) lists four things a removal request must contain in writing: a signature, identification of the depiction, a good-faith statement, and contact information. Only a valid request starts the 48-hour clock, so the intake refuses a request missing any of them.

Section 02 — the append-only evidence log

Every row below is one `td_events` record: `at`, `actor`, `action`, `detail`. Rows are written once and never edited. A field the platform never supplied prints empty rather than as a plausible value.

SECTION 03 — THE 48-HOUR CLOCK

The clock started at intake, 2026-08-09T14:22:06Z, and the operator recorded removed at 2026-08-10T09:41:33Z — 19 hours 19 minutes later, inside the 48-hour window. The Act also requires reasonable efforts to find and remove known identical copies within the same window; TrustDesk records the deadline and the decision, and does not itself review content or remove anything from the platform.
